## Residential Swimming Pool & Hot Tub Safety Act Requirement

(WE) acknowledge that a new swimming pool, spa or hot tub will be constructed or installed at \_\_\_\_\_ and hereby affirm that one of the following methods will be used to meet requirements of Florida Statute 515 and Chapter 41 of the Florida Residential Building Code.

\_\_\_\_\_ The pool will be isolated from access by a barrier that meets the pool barrier requirements of FS 515.27 and 515.29 and Section R4101.17.1.1 through R4101.19 of the Florida Residential Building Code.

\_\_\_\_\_ The pool will be equipped with an approved safety pool cover that complies with ASTM F1346-91 (Standard Performance Specifications for Safety Covers for Swimming Pools, Spas and Hot Tubs) as allowed by Florida Statute 515.27 (b).

\_\_\_\_\_ All doors and windows providing direct access from the home to the pool will be equipped with an exit alarm complying with UL2017 that has a minimum sound pressure rating of 85 decibels at 10 feet as specified in section R4101.17.1.9 of the Florida Residential Code.

\_\_\_\_\_ All doors providing direct access from the home to the home to the pool will be equipped with a self-closing, self-latching device with positive mechanical latching installed a minimum of 54 inches above the threshold which is approved by the authority having jurisdiction as specified in section R4101.17.1.9 of the Florida Residential Code.

\_\_\_\_\_ The above ground pool structure will be used as the barrier and will have sides at least 48 inches above finished grade. If the means of access to the pool is a ladder or steps they shall be capable of being secured, locked or removed as specified in sections R4101.17.1 and R4101.17.1.10 of the Florida Residential Code and Florida Statute 515.

I understand that I must comply with the provisions of the Residential Pool Barrier Requirements, contained in Section 4101.17 of the 5th Edition of the Florida Residential Code and Florida Statute 515.29, in order to pass the Final Inspection.
