GENERAL DESCRIPTION:

This is technical multiple disciplined inspection work enforcement of county codes and ordinances regulating building construction, alterations and repairs. Work is performed under the general direction of the Chief Building Inspector.

ESSENTIAL JOB FUNCTIONS:

1. Conducts field inspections of construction work for compliance with Florida Building Code, Florida Statutes, Administrative Rules, building codes, statutes and local ordinances.
2. Insures construction compliance with plans, engineering and other construction documents.
3. Climbs ladders, enters attics, crawlspaces and confined areas to insure compliance.
4. Photographs, logs, documents and completes computer entries of all inspections.
5. Composes reports and letters documenting field conditions, deficiencies and requirements.
6. Answers the phone, returns calls and assists with customers at the permit counter.
7. Researches code interpretations and consults with contractors, manufacturers and engineers.
8. Investigates complaints of permitted and non-permitted work and issues stop work orders.
9. Maintains a current working knowledge of new products, techniques and code changes.
10. Performs other job related duties as requested or assigned.

MINIMUM QUALIFICATIONS:

1. High School Diploma or equivalent G.E.D. required.
2. 5 years combined experience in the construction or related field.
3. I & II Family Dwelling Inspector's Certification per Florida Statue 468 or ability to obtain a Provisional license.
4. Valid Florida Driver's License with a good driving record.
