It is understood and agreed that the permit herein granted is only to the extent of the County's right, title, and interest in the land to be entered upon and used by the Permittee, and the Permittee shall, at all times assume all risks of construction and shall indemnify, defend, and hold harmless Hardee County, employees and assignees from and against any and all loss, damage, cost or expense arising in any manner on account of the exercise or attempted exercise by the Permittee of the aforesaid rights and privileges.
